7 Significant accounting policies

a) Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent liabilities as on the date of the financial statements and the results of operations during the reporting period. Although these estimates are based upon management's best knowledge of current events and actions, actual results could differ from these estimates. Difference between the actual results and estimates are recognised in the period in which the results are known/materialised.

b) Revenue recognition

Revenue on account of Fees & Subscription is recognised on receipt basis.

c) Contingent Liabilities

Liabilities which are material and whose future outcome cannot be reasonably ascertained are treated as contingent and not provided for and disclosed by way of notes to the accounts.

e) Cash and Cash equivalents

Cash and Cash equivalents in the balance sheet comprise cash at bank and in hand and short-term investments with an original maturity of three months or less.

f) Corpus Fund

Corpus Fund refers to funds contributed by founder/promters/members of the Political Party.

g) General Fund

- (i) General Fund includes the funds contributed by the members of the party other than the members referred to in corpus fund.
- (ii) The balance, if any, in the income and expenditure account after appropriation, i.e. surplus(deficit) is transferred to this fund.

8 Notes to Accounts

- a) The Accounts are prepared on accural basis.
- b) Balance of other liabilities, sundry creditors, sundry debtors, loans and advance are subject to confirmation.
- c) The closing cash balance has been taken by us as certified by the Institution.
- d) Partial payment of Adutit fees has been paid by account payee cheque of Rs. 20,000 by president of political party Mr. Satish Jalan. Further the party has paid the same sum to Mr. Satish Jalan by cash.
