
2. We certify that the balance sheet and the income & expenditure account are in agreement with the books of account maintained.

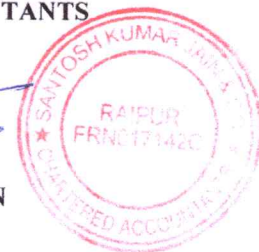

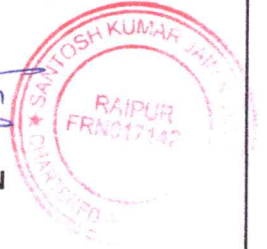
