

To the Members,

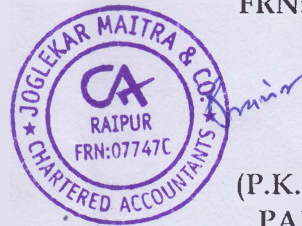

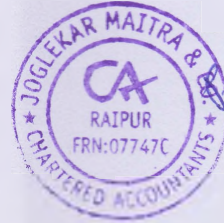

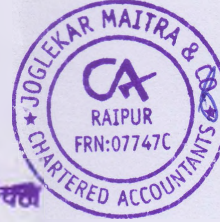
