

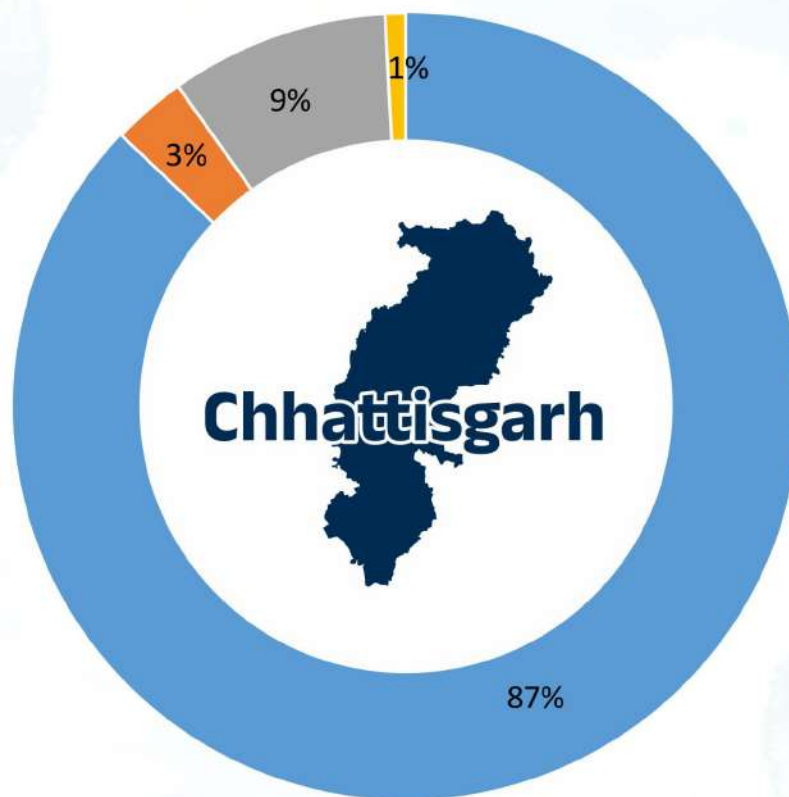

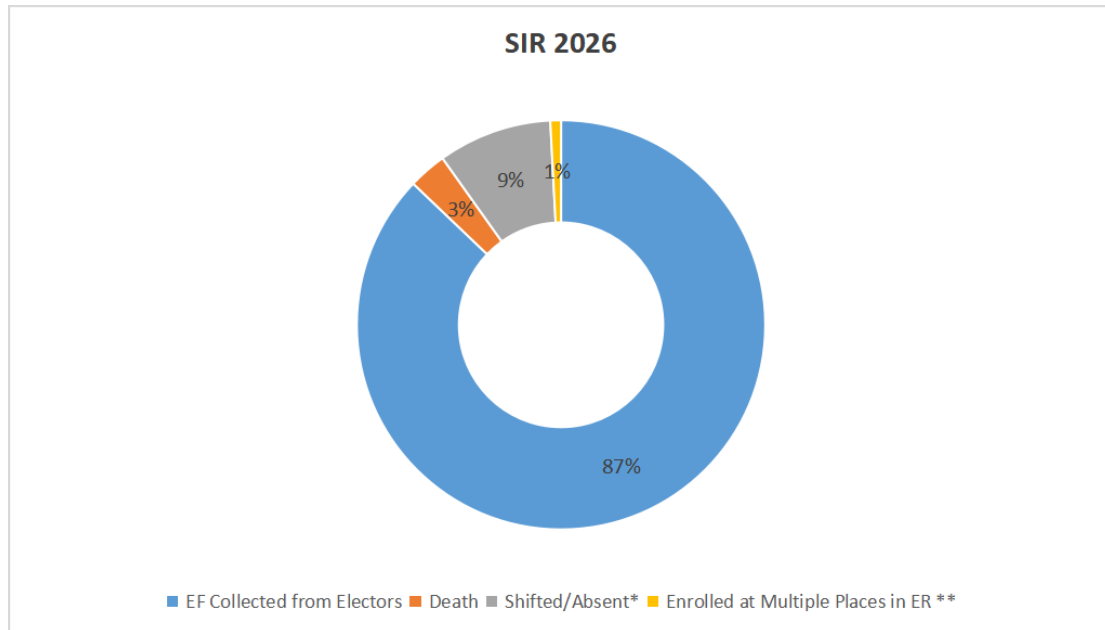

## Chhattisgarh SIR: Key Findings of Enumeration Phase From 04.11.2025 to 18.12.2025

**\*The BLO (Booth Level Officer) did not find these voters or they did not return the enumeration form because:**

- They have already become voters in another State/Union Territory, or
- They were not found present, or
- The form was not submitted by December 18, 2025, or
- For some reasons, they were not interested in registering as a voter.

**Genuine voters can still be added back in electoral roll during the Claims and Objections phase (23.12.2025 to 22.01.2026).**

**\*\*The name of the electors found enrolled at multiple places in Electoral Rolls will be retained only one place.**

The Election Commission of India (ECI) is implementing the Special Intensive Revision (SIR) of the Electoral Rolls in Chhattisgarh with a clearly defined objective to ensure inclusion of all the eligible electors and exclusion of all the ineligible electors with full transparency at every stage of the process. The key aims and measures undertaken under SIR are outlined below

## **1. Participation of all Voters and all Political Parties:**

Out of 2,12,30,737 electors, over as on 27.10.2025, 1,84,95,920 electors have submitted their Enumeration Forms as on 18.12.2025 reflecting an overwhelming participation in the first phase of SIR.

The successful completion of this phase is the result of coordinated efforts of DEOs of 33 districts,, 90 Electoral Registration Officers (EROs), 377 Assistant Electoral Registration Officers (AEROs), & 734 Additonal Assistant Electoral Registration Officers (AAEROs), and BLOs deployed at 24,371 polling booths. supported by 30000+ volunteers. Field representatives of all 7 recognised political parties, including their District Presidents, also actively participated, with as many as 38,846 Booth Level Agents (BLA) appointed by them.

## **2. Ensuring No Eligible Elector is Left Behind**

a. To ensure universal awareness and participation, during the enumeration period, CEO, DEOs and EROs conducted extensive awareness campaigns and held multiple meetings with political parties to explain the process and share progress updates.

b. BLOs also conducted booth-level meetings with BLAs, who were permitted to file up to 50 Enumeration Forms per day to ensure their active involvement BLOs carried out house-to-house visits to all electors whose names were in the rolls as on 27.10.2025 to distribute Enumeration Forms, followed by at least three visits for collection. BLAs and volunteers also made dedicated efforts to ensure that no eligible elector was missed

## **4. How to Check Your Name in the Draft Voter List**

- From the draft voter list available with local Booth Level Officer (BLO)
- From the ECINET mobile app.

## 5. What to do if your name is not found in the draft voter list:

If name is not found in the draft voter list, to include the name, Form 6 is required to be filled and submitted along with Annexure-IV and other documents

## 6. Application Forms:

Form-6	<b>New Voter Registration</b> Fill Form 6 if you are 18 years or above or you will turn 18 in few months
Form-6A	<b>New Voter Registration (NRI)</b> Fill Form 6A if you are a citizen of India and has not acquired citizenship of any other country.
Form-7	<b>Deletion</b> Fill Form 7 to get name deleted from the existing electoral roll.
Form-8	<b>Correction Of Entries</b> Fill Form 8 to get EPIC with updated or replacement or marking of PwD.

## 7. Where to submit your application form:

- Citizens can submit their application forms to their Booth Level Officer (BLO), or
- Application form can also be submitted online through the ECINET mobile app or via <https://voters.eci.gov.in>.

## 8. Major Initiatives Taken:

- **Handholding:** BLOs were supported by Anganwadi workers, designated officers/employees, volunteers, and IT-enabled officers.
- **Felicitation Ceremony:** Booth Level Officers who completed their work within the time limit were honored at the district level.
- **Incentives:** On the occasion of Voter's Day 25 January 2026, 280 such BLOs will be honored with incentives.
- **Capacity Building:** More than 98% mapping was ensured through frequent training, doubt-clearing sessions, and video conferencing.
- **Awareness through Social Media:** Information regarding SIR (Special Intensive Revision) aspects/processes was shared to make it easier to understand the process and fill out forms.
- **Community Model for Digitization:** Group-based digitization was carried out in areas with weak network connectivity.
- **Special Urban Camps:** Special camps were organized in the wards of all urban bodies with the cooperation of Municipal Corporations and Municipalities to digitize forms.
- **Motivating New Voters:** To engage new voters in the voting process and register them in the voter list, voter awareness programs were organized in all colleges across the state.

## **9. Inclusion of Young Voters:**

- Young voters who have turned 18 on or before 01.01.2026, or will turn 18 by October 1, 2026, are being encouraged to apply using Form-6 along with the necessary declaration provided in Annexure-IV.
- Special camps will be organized across the state to add the names of all eligible young voters in the electoral roll.

## **10. Participation with Electors and Political Parties:**

Booth-level lists of electors reported as deceased, permanently migrated, untraceable, or whose forms were not received were shared with the Booth Level Agents appointed by the political parties for verification.

## **11. Assistance by Election Staff and Volunteers:**

- The entire election machinery, with the help of volunteers, is assisting voters, especially senior citizens, PwD (Persons with Disabilities) voters, and vulnerable groups. Volunteers are facilitating coordination with government departments to reduce the burden on voters.
- To provide special assistance to senior citizens, the differently-abled, and vulnerable sections, more than 30,000 volunteers have been deployed across the state. Help desks and IT desks have been established at the district and tehsil levels.

## **12. Grievance Redressal During Counting:**

- All necessary information for the general public was provided from time to time by the Chief Electoral Officer and the District Election Officers of the 33 districts through press notes, voter awareness videos, etc. Every complaint received on media and social media was resolved individually.

## **13. Scrutiny of Draft Electoral Roll:**

- As per SIR orders, the draft electoral roll was published on December 23, 2025. Both printed and digital booth-wise copies of the electoral roll will be made available to political parties and will be displayed on the CEO Chhattisgarh website: <https://ceochhattisgarh.nic.in/>.
- During the Claims and Objections period (December 23, 2025, to January 22, 2026), applications can be submitted to add names of eligible voters and remove names of ineligible voters.

## **14. No Deletion without Due Process:**

- As per Para 5(b) of SIR guidelines, no name can be deleted from the draft roll published on 23<sup>rd</sup> December, 2025 without notice and a speaking order by the ERO/AERO. Any aggrieved elector may appeal to the District Magistrate and thereafter to the Chief Electoral Officer under Section 24 of the RP Act, 1950.

- The Commission reiterates its firm commitment to a transparent, participative and inclusive revision process, ensuring that no eligible elector is left out and no ineligible name remains in the Electoral Roll.
