#### **AUDITOR'S REPORT**

#### Report on the Financial Statements

We have audited the accompanying financial statement of M/S AZAD JANTA PARTY NEAR BRIGHT MUKHABADHIR SCHOOL KADAMBARI NAGAR DISTRICT DURG (C.G.) which comprise the Balance Sheet as at 31<sup>st</sup> March 2023, the Statement of Income and expenditure account and Receipt & Payment account for the year ended 31.03.23.

#### Management's Responsibility for the Financial Statements
